



Recruit

Enter the classified and approved PD into the SPD Library and begin the hiring process.

Produce comprehensive job evaluations, which reference the classification standard utilized, narrative summaries for each factor. point ratings, and supportable references.

Finalize

In 2020, FYI scanned, uploaded, and indexed over 1,100 position descriptions within SharePoint over a 3-month period. This transition impacted all Divisions within the DEA, allowing hiring officials and HR Specialists to easily access PDs and expedite recruitment actions.
